### Pastoral Report Annual Report 2022

On February 1, 2023, I will have been here for four years. It hardly seems possible. Much has happened over these years, but my reflections will primarily focus on 2022.

Whereas Covid still is around (and many in our congregation caught it in 2022, despite the vaccines), we have not had disruption in having in-person worship, coupled with our live stream. (Covid related issues took major space in the 2021 Annual Report). Our combined 10am service is now around 20 months old.

Aside from the people in our congregation, our greatest missional asset has been our building. We were delighted to welcome another worshipping body to call this place home: The Evangelical World Pentecostal Church who hold their services in the Old Dining Hall in Swahili. Stop in some Sunday afternoon and just listen to their worship. It is a bit more animated and louder than ours. On Saturdays they spend about 5 hours in prayer and fasting.

We are still richly blessed to have the Beacon of Light congregation call our building home as well. Not only do they have Sunday afternoon worship services, but they are very involved in the neighborhood. We have been delighted to combine services with them, and for both Pastor Marcy and Pastor Dedric Roundtree fill our pulpit when I have been gone. We also joined forces to host a Back-to-School Giveaway before school resumed this fall. Our congregation rallied around this endeavor, so we could provide laundry detergent (and laundry bags), plus give out a host of gift cards to help the students buy new shoes. Another gift given at this event was prayer for each family.

If you look closely at our calendar, you will see the variety of groups and activities, we are able to host. Not only will you find the above churches listed you will see Women in Action (a women's AA Group) Building Better Bridges (Bridge club), A large community choir that meets to practice, and a diverse group of other organizations that use it periodically like a condo association, NA, having area wide spring and fall events, and this year a New Year's Eve celebration and Valentine Party. We have training going on for African Americans seeking to own a home (a Beacon of Light, Collins Community Credit Union, and a Neighborhood Housing Alliance endeavor). Session approved in December for Kingdom Community Center to hold a fundraiser in our parking lot, hosting a Car Show. The list goes on.

Collaboration and partnering are key for churches today, and we have been privileged to embark on many. Another exciting endeavor has been leaders from Westminster and First Presbyterian meeting to see if there are areas where shared ministry makes sense. At our last 2022 meeting in November, we decided to propose to our sessions that we have shared worship on February 12 & 19, with each church hosting one of the services.

It was further a joy for Jill and I to lead pottery this fall/winter with the neighborhood youth group lead by the Roundtrees. Our project was making pottery crosses. We now wish finally in the New Year to have a class for those from WPC (along with friends).

Personally, I continue to enjoy serving at Loaves and Fishes on a somewhat regular basis, getting to interact with many whose life situation is different than mine, particularly the homeless. I look forward to 2023 to see what kind of opportunities he will lay before us. I hope you do, too. Please do not hesitate to call or email me if you have any questions, needs or ideas. Together we can make a difference!

### FOUNDATION PRESIDENT'S 2023 FISCAL YEAR REPORT

The members of the Board of Directors of the Westminster Presbyterian Church Foundation for the fiscal year ending September 30, 2023, were Bill Moss, President; Jim Shanklin, Vice-President; Pam Richardson, Treasurer; Joyce Sedlacek, Secretary; Jim Fine; Jan Kosowski; and Nancy Evans. Ex-officio members who attended meetings during the fiscal year were Warren Feerer, Finance Committee Moderator; John Swanson, Church Treasurer; and Pastor Roger Grandia.

For the upcoming year, the Foundation has elected Jim Shanklin, President; Pam Richardson, Treasurer; and Jan Kosowski, Secretary. Bill Moss is recognized for his nine years of service to the Foundation as he has completed three consecutive three year terms. Steve Allsop is recognized for his four years of service to the Foundation. We also thank Joyce Sedlacek for her service as Secretary as she will continue on the Foundation as an at large member.

#### WPC Foundation Mission Statement:

"The WPC Foundation exists to serve the purposes and serve the ministries of Westminster Presbyterian Church of Cedar Rapids, Iowa. The gifts and endowments to the Foundation (The Principal) shall be held in perpetuity. It shall be the duty of the Board to invest and manage these funds to earn as much total return as possible while safeguarding the Principal. A major portion of the "spendable income", as determined by the Foundation Board, shall be available to the session of the Church."

Our challenge this year was to provide \$22,500 quarterly in four equal payments for the church needs. This was especially challenging due to the continuing volatile economy in 2023. Please observe the figures supplied by our treasurer, Pam Richardson.

The Foundation Board feels incredibly good about our move to Capital Investment Services, Inc. We left our Family and Friends Fund with Greater Cedar Rapids which had a value of \$25,776.18 on December 30, 2023. Hills Bank is serving as our banker for receiving and expending funds. Counting all funds, our Current Value as of December 31, 2023, is \$1,670,726.29, a net change of (1.5%) in value since December 2020

If you desire to contribute to the Foundation, we have several options available for your estate planning. Talk to a board member about our options. Some of our legacy partners are giving an annual or semi-annual contribution to the Foundation, taking advantage of the growth of the stock and then making a one-time final gift. These contributions from the Foundation are used for everything including building repairs, maintenance, emergencies and supplemental general purpose and budget shortfalls.

All the investment data for this fiscal year is available for review in the church office.

Actions in 2023

January:

Gale Smetana's full-time position changed to part-time as Communications Coordinator and Special Events Coordinator.

Lisa Freeman was hired as Office Manager/Administrative Assistant (part-time).

A.J. Plummer was hired as Interim Director of Music /Choir and Praise Band Director with other duties as needed for our music ministry (part-time).

David and Deb Liljedahl were hired as accompanists for Sunday Services and for the choir. July:

A.J. Plummer, our Interim Director of Music/Choir and Praise Band Director, resigned his position as he and his wife would be moving to Colorado. We are extremely grateful for the time A.J. spent at Westminster over the years.

August:

David Liljedahl was hired for the Interim Director of Music position to include duties as Choir Director and Praise Band Director with other duties as needed for our music ministry (part-time). Deb Liljedahl agreed to continue in the accompanist position (part-time). We are thankful for the Liljedahl's exceptional talent and their willingness to serve at Westminster.

October:

The Personnel Committee regretfully recommended to the Session that at the end of 2023 the nursery be discontinued, and the Nursery Attendant positions be eliminated. We want to extend our thanks and appreciation to Lindasy (Meade) Hopp and Jill Lorimer for their faithful service to Westminster.

November:

Staff reviews were conducted.

Looking ahead to 2024:

Gale Smetana has decided to step away from her office duties here at Westminster but will continue to serve in our livestream ministry. Therefore, we will need to hire a person to take on duties and responsibilities performed by Gale in the office (part-time position).

Due to Tina Mueller's retirement, we will need to hire a bookkeeper (part-time position).

### **2022 WPC PROPERTY COMMITTEE REPORT**

**COMMITTEE MEMBERS:** Maggie York, Jan Kosowski; Brian Read and Terry Perkins Co-Moderators The Property Committee would like to recognize **Mark Tyler** for his contribution, over many years, to the Committee's work, as well as for his habitual volunteer efforts maintaining the building grounds.

We also acknowledge and appreciate that **Dave Cosgrove** has volunteered to assist with building general maintenance. Dave's keen eye provides valuable and timely identification of issues to bring to the committee's attention so that they can be evaluated and corrected before they become critical.

**The Committee's responsibility** is management and oversight of the scope, budget, and execution of work related to regular maintenance and discretionary improvement of WPC's property. Maggie York is instrumental in ensuring that the multitude of annual building inspections, required reports, and archiving of related documentation are done in good order.

### Following is a summary of the 2022 projects.

### JANUARY, FEBRUARY, MARCH

The room which was formerly the pastor's study was restored: water damage was fixed with upgraded light fixtures and heat tape was installed to prevent ice dams on the roof above.

Jan Kosowski re-negotiated a recent invoice from Modern Piping to less than half of the original, recovering \$7,500!

### APRIL, MAY, JUNE

As part of the Session's sanctuary enhancement task force plan, the heavy railing between the choir and the platform was removed in order to provide expanded space for the Praise Band.

Damage to the satellite parking lot fences caused by the 2020 derecho resulted in a parking lot code violation. Much of the damaged fencing was removed but construction of new fences was postponed until 2022. Remaining broken fencing was removed (**Doug Horton** and **Truman Johnson**) and new fencing was

contracted and installed ahead of the pending sale of the parking lot property.

### JULY, AUGUST, SEPTEMBER

The Parking lot resurfacing and striping was completed.

In 2021 the entire alley sidewalk developed a horizontal crack which caused large sections of the curb to break into pieces. The cause was determined to be improper location of the reinforcing rods when the sidewalk was constructed. Additional deterioration of the sidewalk surface due to the same cause was discovered in 2022 after winter. The sidewalk was removed and replaced.

The Committee presented a **motion to the Session** to approve weekly use of the old dining room and youth room by Pastor Theo's congregation. His congregation committed a tithe of their offering for this use, which covers the minimal cost to WPC. The motion was approved.

The Praise Band's microphone and other electrical cords have been routed through the choir entry doorway and along the stage baseboard. As a result, the door could not be closed, and the cords presented a trip hazard. Ed Kosowski re-routed the cables through the back wall so that they pass directly into the equipment closet on the other side.

### **OCTOBER, NOVEMBER, DECEMBER**

In support of the Building Exterior Maintenance task force, drone photographs of the Belfry, the highest (literally and figuratively) priority stonework task, were obtained, reviewed, and sent to the contractor. The first phase of this work begins in 2023.

Jan Kosowski secured a bid to repair the narthex outside stairs and railings which present a hazard. This bid is significant as previous requests for quotation resulted in no bids. The existing railings will be restored, with new posts attached and secured in new concrete without affecting the major portion of the steps which remain serviceable. This work could not be scheduled during the 2022 construction season and was postponed until spring of 2023.

Flat Roof leaks were discovered and were patched by DrySpace.

After reviewing the business case for installing solar panels on the south roof, the Property Committee brought this topic forward to the Session. The session noted that an alternative would be for the Church to purchase a share of a solar energy farm located elsewhere. Incentives include significant reduction in electricity costs and Government subsidies. The Committee later recommended that solar energy conversion not be considered at this time.

The **Session approved a motion** from the Property Committee for **replacement** of the broken sanctuary **pyramid window** with tinted glass, and approved solicitation of congregational donations toward this project. The Committee accepted a bid from Allied Glass for \$3,600, with 75% covered to date by contributions. The schedule is weather dependent.

The Committee participated in the annual review of the Church's 2023 property and liability Insurance policy with Rich Mohon, the agent from Assured Partners.

### **PROJECTS TO BE ADDRESSED IN 2023 INCLUDE:**

- Canopy repair (low priority)
- Shingled (1904) roof: contractor to perform post-derecho inspection and advise if any action required.
- FLC light non-functioning light fixtures, conversion to LEDs; task to be included in the sanctuary lighting improvement bid request.
- Sanctuary pyramid window glass replacement
- Old maintenance room (basement): significant floor damage at the east wall
- Third floor classroom adjacent to balcony: significant deterioration of part of the east wall and ceiling
- Small parlor: northwest corner, broken ceiling recessed light fixture.
- The room which was formerly the pastor's study: There is still a need for carpet cleaning and ceiling repair, low priority.

Although it is not part of the Committees official work, when necessary, we perform a share, within our capabilities, of the heavy lifting necessary to accomplish our objective, which is to be good stewards of the gift entrusted to the Westminster congregation.

### **Beyond Food:**

L & F continues to operate out of the space in the Tanager building for \$800/month. This space has been a blessing for both the clients and for the volunteers. This year has seen an increase in the number of clients served, in particular there are many, many new faces. This has caused L & F to expand our offerings to pay particular attention to those who are struggling with homelessness, loneliness, and poverty. While we have continued to partner with CEC, Public Health nursing, Buffalo Ridge Orchard, and Cranksgiving, we have also conducted several drives for clothing such as t-shirts, socks, and gloves. We have had several clothing giveaways, as well as towels, blankets, and many household items for preparing, serving, and storing food. Some of these items have come to L & F through members of the congregations as they downsized or passed away. We continue to collect travel sized personal care items, can openers, and plastic utensils that are useful to homeless people. It is all good.

More importantly, the volunteers have come to realize that our personal connections to our clients, really our friends, and to each other, are what Loaves & Fishes is really about. Notes from some of our clients this year re-enforce that not just caring for, but <u>about</u> our clients makes the pantry the face of God in these troubled times. Some of the cards we received said "Thank you for showing everyone who comes to L & F God's true love." and "We can't thank you enough for all the help you've given us the past few years. Everyone has always treated us with dignity and respect, and we've seen you treat others the same way. Your dedication and many volunteer hours are so appreciated."

We are keenly aware of all the Saints that have gone before us in this mission, recognizing that their foresight is the foundation on which L & F exists.
